Highlights of the Prime Minister's Address from the Red Fort on the 73rd Independence Day



70 days of path breaking decision-making

- To revoke Article 370 and 35A within 10 weeks of the formation of the new Government is a significant step towards fulfilling the dream of Sardar Vallabh Bhai Patel.
- What was not done in the last 70 years was accomplished within 70 days. The abrogation of Article 370 and 35A was passed in both Rajya Sabha and Lok Sabha by two-thirds majority.
- We have enacted law against Triple Talaq to protect the rights of our Muslim women.
- Transfer of about **Rs. 90,000 crores** to farmers' bank accounts is in progress to those who are beneficiaries of **PM Kisan Samman Nidhi Yojana**.
- Pension scheme to farmers and small entrepreneurs has been put in place which was never imagined earlier.
- To address water crisis, a new dedicated Jal Shakti Ministry has been created.

• Centre and States will together take forward the **Jal-Jeevan Mission** and an amount of more than Rs. 3.5 lakh crores has been earmarked for this.

- As a Tourist Destination, India can become a wonder in the world. All Indians should promote tourism, because tourism provides more jobs with less investment and also strengthens economy.
- A stable government provides for policy predictability and a stable system creates international trust. The world is looking at India with admiration for its political stability.
- It is a matter of pride for India that we are progressing at a high growth rate with price rise under control.
- The fundamentals of our economy are very strong and reforms like GST & IBC have created a new faith in the system.
- Our investors should invest more, earn more and generate more jobs. We should stop viewing our Wealth Creators with suspicion: they deserve greater respect.
 Greater wealth creation will lead to greater distribution and help in the welfare of poor people.
- 'Made in India' products, would improve the rural economy and give a boost to the MSME sector.

- In the coming days, 1.5 lakh wellness centers will be created all over the country.

Whichever government comes to power, it works for the betterment of the country by enacting laws in the Parliament. No matter which party or coalition is in power, this work never stops. There is a lot of debate both inside and outside the Parliament when laws are

enacted and made, a lot of debate and brainstorming occurs and serious arguments are put up over its importance and effect. The laws that are enacted after undergoing this process are beneficial for the people of the nation. However, it's unfathomable that so many laws are enacted in the Parliament but are not implemented in a particular region of the country. Even previous governments who were hailed after enacting a law couldn't claim that the same law would be implemented in the Jammu & Kashmir region.

More than 1.5 crore people of Jammu & Kashmir were deprived of the benefits of laws that were enacted for the benefit of the people of India. Imagine children in rest of the country have a right to education while children in Jammu & Kashmir were deprived of this right. The daughters of Jammu & Kashmir were deprived of the right that our daughters have in rest of the states. In all the other states, Safai Karamchari Act was enacted for hygiene workers but the workers of Jammu & Kashmir were deprived of this. In other states, strict laws were enacted to stop atrocities on Dalits but no such laws could be implemented in Jammu & Kashmir. To protect the rights of blue-collar workforce, Minimum Wages Act was enacted and implemented in all the other states while such a law is only found on papers in the state of Jammu & Kashmir. In all other states, our brothers and sisters from Scheduled Tribes got reservation while contesting elections, but such a thing is unheard of in the state of Jammu & Kashmir.

Friends, I am fully confident that, following the abrogation of Article 370 and 35-A, Jammu and Kashmir would soon come out of its negative effects.

Brothers and sisters, in the new system, the priority of the central government would be to keep state government employees and Jammu and Kashmir police personnel at par with the state government employees and police personnel of other states in terms

of facilities. In Union Territories, the government provides many such financial facilities like LTC, House Rent Allowance. Education Allowance for children. Health Schemes etc., most of which are not provided to the employees of Jammu and Kashmir government. Such facilities would soon be provided to the employees of Jammu and Kashmii government and state



police personnel following a review.

Friends, very soon the process to fill in the vacancies of central and state government will be initiated in Jammu and Kashmir and Ladakh. This would provide adequate employment opportunities to the local youth. Besides, public sector units of the central government and big private sector companies would also be encouraged to provide new employment opportunities. Apart from the above, Army and para military forces would organize rallies to recruit local youths. The government would also expand Prime Minister's Scholarship Scheme so that more and more students can get its benefit. Jammu and Kashmir also

suffers huge revenue loss. The central government will ensure to minimize its impact.

Brothers and sisters, after abrogation of Article 370, the central government has decided to keep the state of Jammu and Kashmir under its administration after putting in a lot of thought process into it. It is essential for you to understand the reasons behind the decision. Ever since the state has been under governor's rule, the administration of Jammu and Kashmir is directly under the central government. As a result, the positive effect of Good Governance and Development have been observed on the ground. The schemes



which earlier remained only in files, have been implemented on ground. Projects pending from decades have been speeded up. We have tried to bring transparency and a new work culture in the Jammu and Kashmir administration. As a result, be it IIT, IIM, AIIMS, various irrigation projects or power projects or the Anti-Corruption Bureau, we have been able to expedite the work on these projects. Besides, be it the projects of connectivity, roads or new rail lines, modernization of the airport, everything is being accelerated.

Friends.

The democracy in our country is very strong; but you will be surprised to know that there have been thousands of brother and sisters living for decades in Jammu and Kashmir who had the right to cast their vote in Lok Sabha polls but were not allowed to cast vote in assembly and local body elections. They are the ones who had come to India following partition in 1947. Should we have allowed the injustice to continue in the same way?

Friends,

I would also like to clarify another important point to my brothers and sisters of Jammu and Kashmir. Your political representative will be elected by you, he will be one of you. The MLAs would be elected just as they used to be elected earlier. The forthcoming cabinet would just be as it used to be earlier. The Chief Ministers would just be as they were before.

Friends, I am fully confident that, under the new system, we would collectively be able to keep the state of Jammu and Kashmir free from terrorism and secessionism. When our Jammu and Kashmir-the paradise on earth, after

I am fully confident that following the abrogation of Artcle 370, once these Panchayat members get a chance to work in the



Ensuring Social Justice to all Sections of Society

Sigh of Relief for Married Muslim Women -Regressive Practise of Triple Talaq abolished

- In a step to protect the vulnerable married Muslim Women, Modi Government has abolished the regressive practise of Triple Talaq.
- Muslim Women (Protection of Rights on Marriage) Act 2019 abolishes Triple
 Talaq. Any pronouncement of talaq by a Muslim husband upon his wife shall be void and illegal.
- Makes Triple Talaq a punishable offence with imprisonment up to three years and fine.





Safeguarding Child Rights: Modi Government amends POCSO Act

- Parliament passes Protection of Children from Sexual Offences (POCSO)
 (Amendment) Bill, 2019 strengthening the act by including death penalty for sexual assault on children.
- It makes the offences against children gender neutral.
- 1023 fast track courts to be set in the country in one year for speedy hearing of POCSO cases.
- 40,000 teachers to be trained for awareness in schools across the country to make children aware about the good and bad touch.

The Transgender Persons (Protection of Rights) Bill 2019: Upholding the rights of Transgender.

- Prohibits discrimination and defines the rights of a transgender person.
- Every transgender person shall have a right to reside and be included in his household.
- No government or private entity can discriminate against a transgender person in employment.

Tribal Welfare

- Go Tribal Campaign' launched to promote the use of tribal products. 'Tribes India' goes global to step up exports of Tribal Products.
- e-Governance Initiatives for Scheduled Tribes Welfare Schemes launched for bringing in greater e-Governance in implementation of welfare schemes for STs.



Minorities Welfare

- A record number of 2 lakh Indian Muslims including 48 percent women to go to Haj this year, that too without any subsidy.
- 5 crore students, including 50 percent girls will be provided various scholarships in the next five years.
- Target set to achieve 100 per cent digitization of Waqf properties across the country in first 100 days.

Ensuring Wage Security

- THE CODE ON WAGES, 2019: Women's equality ensured.
 - Historic Act removes discrimination against Women and ensures equal wages as their male counterparts.
 - Ensures statutory protection for minimum wages and timely payment of wages to approximately 50 crore workers of organized as well as unorganized sector.
 - No employer shall pay to any employee wages less than the minimum rate of wages notified by the Government.
 - Many un-organised sector workers like agricultural workers, painters, persons working in restaurants and dhabas and chowkidars, who were outside the ambit of minimum wages, will get legislative protection of minimum wages.
- Pradhan Mantri Laghu Vyapari Maan-Dhan Yojana, 2019:
 - Modi Government approved Pradhan Mantri Laghu Vyapari Maan-Dhan Yojana, 2019 to provide minimum assured pension of Rs 3000 to small traders after attaining age of 60 years.
 - Around 3 crore small traders will be benefited from the scheme.
 - All shopkeepers, retail traders and self-employed persons to benefit
 - Govt reduced rate of contribution under ESI Act from 6.5% to 4% for both employees and Employers. It will benefit 3.6 crore employees and 12.85 lakhs employers.



Protecting the poor from financial frauds

- The Modi government approved the Banning of Unregulated Deposit Schemes Bill, 2019



Towards Commanding Water Security

Formation of Jal Shakti Ministry

- Fulfilling a promise made in their manifesto to urgently but comprehensively address water-related issues, Modi Government formed the Jal Shakti Ministry.
- Water management and access to safe drinking water has become part of the public discourse, mainly thanks to PM Modi's continuous focus on it.



- Total 40 Bills (33 in Lok Sabha and 07 in Rajya Sabha) were introduced in the
 parliament during the Budget session of 17th Lok Sabha. 35 Bills were passed by
 Lok Sabha; 32 Bills by Rajya Sabha and 30 Bills passed by both the Houses of
 Parliament.
- The passage of 30 Bills by both the Houses is a record in single first/effective Session after constitution of the Lok Sabha.
- The productivity of Lok Sabha was approximately 137% and that of RajyaSabha was approximately 103%.



Repealing 58 redundant laws

- After the Modi government came in 2014, over 1,000 redundant laws were repealed. Now, in 2019, it cleared a bill for repeal of 58 redundant laws.
- Some of them ease the lives of people and ease business since they were outdated but could still be used to harass people.




Strengthening the Judicial Apparatus

- Empower NIA to conduct raids anywhere without the relevant State government's prior permission.





- Corporate tax rate brought to 25% for companies with annual turnover up to Rs 400 crore. This threshold used to be Rs 250 crore earlier. This will cover 99.3% of all companies.
- Credit Guarantee Enhancement Corporation (CGEC) will be set up in 2019-20, to deepen markets for long-term bonds on infrastructure sector.
- The government is to expedite streamlining multiple labour laws into a set of four labour codes.
- Stand Up India' Scheme, to promote SC/ST entrepreneurs to start their own ventures, is to continue till 2025.

- Allows corporate restructuring of NPAs like acquisitions, mergers and demergers where the CoC may decide upon taking haircuts to allow for a possible resolution.

Special Economic Zone (Amendment) Bill, 2019

- SEZ (Amendment) Bill 2019 passed by the Parliament, will enable any
 entity to set up a unit in SEZs, including Trusts. This would help boost

- National Medical Council Act aims to reduce the burden on students, bring down costs of medical education, simplify procedures, help to enhance the number of medical seats in India, ensure quality education, and provide wider access to people for quality healthcare.

- On a related note, the academic year 2019-20 witnesses the biggest addition

Central Educational Institutions (Reservation in Teachers' Cadre) Bill, 2019 passed by Parliament

- The Bill considers the University/College as one unit restoring the earlier reservation system based on 200-point roster.
- Decision is expected to improve the teaching standards in the higher educational institutions by attracting all eligible talented candidates belonging to SCs/STs/SEBCs/EWS categories.

Making Higher Education Reachable: 2 New Central Universities in Andhra Pradesh

 Central Universities (Amendment) Bill, 2019 passed by Lok Sabha seeks to establish two new universities in Andhra Pradesh - the Central University of Andhra Pradesh and the Central Tribal University of Andhra Pradesh.

'Institution of National Importance' status to 4 NIDs

- Act seeks to confer Institute of National Importance status to the four new National Institutes of Design(NID)
- The four new NIDs at Andhra Pradesh, Madhya Pradesh, Assam and Haryana will be declared as Institutions of National Importance.

- Chandrayaan 2 will propel India to an elite list of four nations that have pulled off a soft-landing on the moon.
- Chandrayaan 2 shall increase our understanding of space and inspire a future generation of explorers and scientists.
- Prime Minister Narendra Modi said that the two "Greatest Lessons" he learnt from the Chandrayaan-II mission are "Faith and Fearlessness".



Security and Defence Sectors

Greater benefits for brave CAPF personnel

- Modi Government grants organised cadre status to Central Armed Police Forces (CAPF) officers. This makes them eligible for several benefits, including Non-Functional Financial Upgradation (NFFU).
- The move benefits thousands of serving officers and many others who have retired since 2006 from the five primary CAPFs or paramilitary forces — CRPF, BSF, CISF, ITBP and SSB.
- The officers will now get better deputation chances as they will be eligible to get empanelled under the central staffing scheme, get enhanced facilities of transportation, house rent allowance, travelling and dearness allowance.

Defence-Technological Advancement and Welfare of Defence Personnel

- Defence Research Development Organisation (DRDO) successfully flight-tested its state-of-the-art Quick Reaction Surface-to-Air Missiles (QRSAM) against live aerial targets from Integrated Test Range (ITR), Chandipur on August 4, 2019.
- Restoration of the 'Ration in Kind' for the officers of the three Armed Forces
 posted in peace areas announced on June 18, 2019. Now all officers of the
 Armed Forces including those in Peace Stations will be getting ration.

Organized Group 'A' Status to Railway Protection Force

India becoming more and more Swachh says the world!

- The Swachh Bharat initiative of the Modi government has led to a reduction in the contamination of groundwater, a UNICEF study observed.
- Villages that were open defecation-free saw lesser fecal contamination, lesser groundwater contamination, lesser soil pollution, lesser food contamination and lesser drinking water contamination.
- The study notes the impact of Swachh Bharat thus: between 2000 and 2014, open defecation decreased by almost three percentage points per year, while from 2015-2019 it came down by of over 12 percentage points per year!

 a World Bank report, improved road connectivity in India triggered a shift from

- It also says the number of babies delivered at home has come down, a major improvement in the health sector.

- He also called for an international combined effort on disaster management.

Modi, great reformer: Enactment of triple talaq bill by India's Parliament corrects a historic wrong

Some dates stand out in history. In the annals of India's parliamentary history July 30, 2019, represents one such day. The passage of the historic triple talaq bill in Parliament's Upper House is not just about enactment of one more law. It is about correcting a historical wrong. It is about restoring honour and dignity to Muslim women. It is about establishing gender equality.

The bill's passage shows the Modi government's commitment to walk the talk on social reforms with a steadfast focus, despite resistance from opposition. It

resistance from opposition. It provides statutory shield to Muslim women who have

been silently bearing the brunt of an utterly sinful practice.

A careful reading of the events during the bill's passage in the Rajya Sabha, as well as those outside Parliament, reveal some important pointers. For one, it brought out the Modi government's relentless efforts to accord social dignity, respect and honour to



women in India. Equally importantly, it also completely exposed the duplicitous intent of the Congress party, which has all along rtreated minorities as a vote bank, perpetuating a deep-rooted inequality that cared little about women's self-respect.

Another interesting facet that has emerged is Congress's diminishing ability to rally other parties around its partisan obduracy. When a government remains dedicated to the cause of public and social welfare, which is the case with the Narendra Modi government, it is only natural for other parties to support it.

The support the triple talaq bill has received from non-NDA parties is welcome. We also appeal to all parties to rise above political differences and offer non-partisan support to such issues that are critical for India to progress as a nation and society.

It is important to analyse Congress's role on triple talaq through the prism of India's recent political history. Congress, which had more than 400 MPs in the Lok Sabha three decades ago, had a great opportunity to change the historical wrong to Muslim women in the Shah Bano case. In 1985, the Supreme Court had ruled in favour of triple talaq victim Shah Bano, made her entitled to an allowance of Rs 500 per month, and had said that the order was in conformity with the Sharia law. However, instead of implementing it, Congress led by then Prime Minister Rajiv

Gandhi succumbed to pressure from clerics represented by Muslim personal board and the lure of vote bank politics and enacted a law to nullify the court's order.

The capitulation appalled even the left-leaning legal luminary, former SC judge Justice VR Krishna lyer. Arif Mohammed Khan, a minister in the then Congress government who had termed the court decision as fair, resigned in protest against the government's decision. Rajiv Gandhi had made Khan believe that he would implement the progressive SC verdict.

The issue had since remained in cold storage for years, and when the Modi government brought it up, there was no change in the Congress's malicious ambivalence. Congress's double standards and divisive politics that existed 30 years ago were on vivid display as it tried subterfuges to thwart the attempt to right the wrong committed by Rajiv Gandhi. The obstructionism only reflected core character that perpetuates appeasement and vote bank politics. The law banning triple talaq marks a huge blow to such politics.

This bill has also thoroughly exposed the socalled liberals in India. Many of these "liberals" who proclaim themselves to be champions of gender justice were conspicuously silent or employed ruses to oppose a bill that sought to empower Muslim

women. The duplicity has exposed that these self-styled liberals are driven by narrow partisan politics instead of humanitarian values.

Importantly, those who question the need to have such a law forget that hundreds of cases of the atrocity that triple talaq was, had been reported after January 2017 when SC outlawed the practice. The brazenness necessitated a strict law to clamp down on the unjust practice. That the law is not against Islam is borne out by the fact that 19 countries including Pakistan, Iran, Iraq and Syria have banned instant oral divorce.

We need to understand that women who fought a long battle against triple talaq didn't have any political motive. They were normal women who showed extreme courage to fight against injustices they were subjected to. They were determined to put an end to this practice and finally won the battle in the country's highest court. By legislating a triple talaq law our government has given a statutory backing to their battle. After all, lawmakers and political parties are duty bound to give voice and right direction to such fights.

Opposition's argument questioning the need for law applicable only to Muslim society is also baseless. Independent India has seen enactment of laws aimed at reforming entrenched practices in other

communities. Hindu Marriage Act, Christian Marriage Act,

and laws to ban child marriage and dowry are examples of such interventions.

Those engaging in opportunistic, narrow political arguments refuse to acknowledge these. Those who question making triple talaq a criminal offence conveniently ignore that several other practices related to Hindu society are considered criminal offence and attract severe punishment.

The Narendra Modi government deserves credit for enacting a law to ban triple talaq. I am sure Modiji will now go down in history as a social reformer in the league of Raja Rammohan Roy and Ishwar Chandra Vidyasagar, who waged struggles to improve the lot of women.

Kashmiris have been let down by a politics that doesn't create economic opportunity.

Economist Albert Hirschman's book. Passions and Interests, is a wonderful meditation on how interests (jobs, skills, enterprises, assets, income, growth) blunt passions. As somebody born in Jammu and Kashmir, I am sad that today's youth there don't have memories of the wonderful place it was to grow up in before 1989. As somebody who went to school in the Valley, I got a great education and strong foundations. As somebody who made pre-exam visits to sufi shrines like Aishmugam, Makhdoom Sahib, and Baba Reshi. I know that the Wahabi intolerance is alien, recent and fragile. As somebody who is a first generation post-reform entrepreneur, I am anguished by the notion that Pakistan — whose GDP is lower than Maharashtra and recently made its 22nd trip to the IMF — has anything to offer anybody in the Valley.

But as somebody who works for a people supply-chain company that has hired someone every five minutes for the last decade, I despair at J&K's economic infancy. I would like to make the case that Kashmiris should spend the next decade creating the economic complexity that blunts passions by creating interests.

A recent conference at Harvard's Centre for International Development offers context. Professor Ricardo Hausmann suggested that the only predictor of sustained economic success is economic complexity, and development was like a game of scrabble; the more letters you have, not only can you make more words, but you can make longer words. Vowels are provided by the government. So development is about creating new letters and vowels. Hausmann believes that new letters in the private sector come from migration, diaspora, venture capital, inbound investment, skills, studying overseas, business travel. Professor James Robinson suggested that inclusive economic systems need vowels from inclusive political systems that distribute political power broadly rather than concentrate, monopolise or hoard it.

Kashmir is an economic infant with low economic complexity. There is no wage premium in handicrafts; carpet weavers get Rs 150 a day while construction labour costs Rs 600 per day (and comes from outside the state). There are only 200 dental and 600 medical doctor seats in the whole state. Less than five per cent of fruits and nuts are processed. Fifty per cent of the state's 50,000 graduates go onto do a masters degree, only to stay out of the labour market. The fiscal deficit is more than twice the prescribed ratio and government debt is 50 per cent of GDP. Private Credit to GDP is less than Bihar and the J&K Bank is a shame. Private investment last year was less than Rs 1,000 crore. More than 30 per cent of families directly work for the government. Land costs as much as in Gurugram. The state accounts for less than 0.7 per cent of India's GDP. There is only one listed company and only one company with a paid up capital of Rs10 crore. Their 28 employment exchanges cost almost Rs 50 crore a year to run and have given few jobs to anybody in a decade. There is no employer in the Kashmir Valley who pays provident fund and no private employer with more than 500 formal employees; hardly fertile soil for economic vibrancy.

The solution is not easy but obvious; a 10-year strategy for education, employment and employability that leverages India's economic complexity. Kashmir needs a new

skill university that spreads higher education with employability. We should convert Hari Niwas into a world class hotel management institute in partnership with ITE Singapore or EHL Lausanne. We must double the direct flights and directly connect Srinagar to Jammu and Delhi with a three-hour and 12-hour train. We need revamped employment exchanges that operate a digital jkrozgar.com that offers job matching, assessments, apprentices, and online degrees. We must temporarily suspend our justified fear of economic planning and commit massive funds to infrastructure and cluster creation. We need a massive design and distribution mission for handicrafts and fruits that raises the realisation of actual producers. Most importantly, we must get the huge, skilled, and motivated Kashmiri diaspora to return and reduce informal self-employment by creating more formal wage employment.

Historians warn against "presentism" and Kashmir's history is too long and complex to belong to any party, community, individual or religion. But it would be foolish to deny that Kashmir's last few maharajas were distracted and disinterested in development. Monarchies or hereditary leadership are ineffective because they think of citizens or voters as a necessary evil that must be

ignored. Naya Kashmir — a memorandum that Sheikh Abdullah submitted to Maharaja Hari Singh in 1944 — outlined a plan to convert J&K from an absolute monarchy to a constitutional democracy, called for universal franchise, freedom of expression and press, ability of women to work in all trades and professions, and a detailed economic plan. Much of what he sought is enshrined in our Constitution but his vision of social justice, economic progress and poverty reduction — which he couldn't achieve in his lifetime — is highly relevant for Kashmir today.

Another Albert Hirschman book, Exit, Voice, and Loyalty, synthesised three choices that confront citizens; leave, speak up, or capitulate. Most Kashmiri elites have economically diversified away from the Valley but the masses can't exit and have lost their voices because of Kashmir's economic infancy and oligopolistic democracy. Political royalty over the last few decades have ensured that Kashmiri democracy lived up to Igbal's warning that "Jamhuriyat ik tarz-e-hukumat hai ki jis mein bandon ko gina karte hain taula nahin karte" (democracy is a system where people are counted but not weighed). The grandiloquence of political royalty about the threats to civilisation sound like scorn for the more prosaic concerns of Kashmiri

youth who are more skilled, entrepreneurial, and aspirational than the past generations. India and J&K are tremendously and permanently intertwined. When one does well, the other does well. And when we both do well, we are unstoppable. Time for Sheikh Sahib's dream of Naya Kashmir.

Modi's four initiatives make Indian e-commerce world's fastest growing; set to grow 8-fold by 2026

Several of Narendra Modi-led BJP government's initiatives are providing a fillip to the growth of the Indian e-commerce industry. While Indian e-commerce is growing at a stellar rate and is the fastest growing online business industry in the world, initiatives such as Digital India, Skill India, Startup India and Make in India are also contributing to the growth of the online trade, CARE Rating said in a report. The industry has witnessed an annual growth rate of 51%, which is the highest globally, and from \$24 billion in 2018, the industry is expected to touch \$200 billion by 2026; over eightfold growth in eight years, according to ASSOCHAM-Forrester study paper as well Retail Association of India (RAI).

Indian e-commerce is also flourishing on the back of higher internet penetration,

increasing quality of internet in the country, advancements in payments and computing on mobility platforms, changing consumer behavior and shopping patterns and the availability of products priced at lower rates on e-commerce platforms. "E-commerce is probably creating the biggest revolution in the retail industry, and this trend will continue in the years to come," the CARE Ratings report said.

Early this year, the government had amended FDI (Foreign Direct Investment) policy in e-commerce for all the entities operating as e-commerce marketplace. Effective from February 1, 2019, the policy changes provide clarity and strengthen the regulatory framework governing FDI in ecommerce marketplace entities in India and also sought to provide a level playing field among online and offline traders. This came in the light of traditional retailers accusing e-commerce entities of distorting market place by predatory pricing and unfair trade practices. It was expected that the tightened norms will considerably affect e-commerce business in India.

In India, the share of electronics and accessories sales is the highest on e-

commerce platforms with over 40% sales happening in these two categories. Lifestyle and apparel is another leading category with over 25% sales. Home & Living account for 5%, food and grocery for 2-3% and other category sales are about 20-30%, according to the report. Currently, the Indian e-commerce landscape is dominated by players such as Jeff Bezos' Amazon and Walmart acquired Flipkart.

Indian Railways passengers will love this! Soon, stream free high-quality movies, videos on trains, stations

Indian Railways to provide aircraft-style entertainment! Soon rail passengers will be able to enjoy movies, entertainment and much more on Indian Railways trains and stations.

RailTel will provide preloaded multilingual content; movies, music videos, general entertainment including TV serials and devotional programmes, lifestyle-related etc in moving trains.

Soon rail passengers will be able to enjoy movies, entertainment and much more on Indian Railways trains and stations. Piyush Goyal-led Railway Ministry has chosen RailTel, a miniratna under the national transporter, to implement this project aimed at providing free content on-demand to

passengers. A railway official told Financial Express Online that a Request for Proposal (RFP) will be issued by RailTel within the first few days of August. The free app will allow Indian Railways passengers to stream movies, news and other entertainment-related content on their personal devices.



"RailTel will provide preloaded multilingual content; movies, music videos, general entertainment including TV serials and devotional programmes, lifestyle-related etc in moving trains. In case of trains, to ensure buffer-free services, media servers will be placed," said the railway official quoted above. "Passengers will be able to enjoy high-quality buffer-free streaming across

personal devices and the content will be periodically refreshed," the official added.

To begin with, the pilot project will involve the provision of the preloaded content on Indian Railways stations that already offer RailTel's free high-speed WiFi service. As Indian Railways completes its ambitious plan to enable WiFi on over 4,000 more stations this year, content on-demand app would be available on these as well and eventually trains!



Indian Railways experimented with aircraft-style on-board infotainment in trains like Tejas Express and Anubhuti coaches for the Shatabdi Express. However, passengers damaged the personalised screens and stole headphones on the inaugural run of the Mumbai-Goa Tejas Express itself. The national transporter has now decided that the use of passengers' personal devices would be a more viable option, especially for long-distance sleeper trains where personalised screens are more difficult to

install.

While the preloaded content made available to passengers would be free, Indian Railways hopes to earn revenue from advertisements that can be displayed on the landing pages and in pre-rolls of videos. The initiative is a step in the direction of earning non-fare revenue. The project has been in the works for some time now. Initially, RailTel was supposed to execute it, but the Railway Board tasked the zonal railways to implement it. However, that failed to take off and now RailTel has been roped in again.

281 Hours, 36 Bills Modi 2.0 Produces Most Productive Parliamentary Session in 6 Decades

The Parliament, in its first session after the Lok Sabha elections, passed not only landmark bills like repealing of Article 370, geographical reorganisation of Jammu and Kashmir, Triple Talaq Bill, new Motor Vehicle Amendment Bill, but also created the record for maximum Bills passed in the last 67 years.

Lok Sabha passed 36 Bills, out of which, in seven cases, there was recorded voting (21 per cent) at some point during the discussion. This is higher than the 16th Lok Sabha, in which, recorded voting was called for 8 per cent of the Bills.

In the first Budget session after the newly elected Modi government took charge, Lok Sabha worked for 281 hours, which is 135 per cent of the scheduled hours. It is higher than any other session in the past 20 years.

The session was extended by the Centre in order to complete legislative business.

Additionally, Lok Sabha spent 46 per cent of its time on legislative business, according to PRS Legislative. The corresponding figure for Rajya Sabha is 51 per cent.

Thirty eight Bills were introduced in the Parliament during the session. Twenty eight of these were passed by both Houses, the highest for any session in the last 10 years. None of the Bills introduced in this session were referred to any committee.

Out of 28 Bills passed by the Parliament, five had been scrutinised by committees in some form during the period of the previous Lok Sabha. A total of 36 per cent of questions were answered orally in the Lok Sabha; the highest in the last 20 years. Question Hour functioned for 95 per cent of its scheduled time in the Lok Sabha and 65 per cent in the Rajya Sabha during this session.

Ninety four per cent first-term MPs participated in a debate during the session; 96 per cent women MPs participated.
